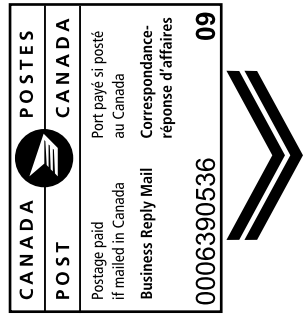
– A VISION FOR QUALITY HEALTH CARE, CLOSE TO HOME

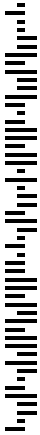
Since then, our hospital has become the heartbeat of our community – a source of pride and a place of healing – that continues to thrive because of the generosity of the people who live here.

WAYS TO GIVE

Many of our donors support the Foundation to show their appreciation for the care they or a loved one has received. Their gift completes a circle of care for each other that goes on to benefit so many other people in our community. The Weatherby Circle honours and celebrates these extraordinary individuals who have kindly supported Peace Arch Hospital Foundation, in one of the following ways:

+ Gift in Will

An outright bequest of cash or a percentage of your estate gifted to the Foundation can be left to benefit a specific area of the hospital, or for the area of greatest need.

- The charitable tax receipt can offset up to 100% of net income, and any unused credit can be carried back one year to reduce tax paid the preceding year.

+ Securities

Significant tax benefits for investments donated to the Foundation, which have either grown or decreased in value.

- Publicly traded securities (including common shares, preferred shares and mutual funds) are eligible.

+ RRSP/RRIFs

An opportunity to leave a future gift to the Foundation without jeopardizing future income.

- Your estate receives a charitable tax receipt to offset some or all income tax payable, and is not subject to probate or estate fees when given directly to the Foundation.

+ Real Estate

Ideal for those with modest cash flow or few liquid assets who would like to give.

- Principle residences
- Qualified farm property
- Land or recreational property

+ Annuities

Provides secure, guaranteed income, free from unpredictable instability often associated with term deposits.

- Donors receive a stable guaranteed income for life that is largely or entirely tax free.
